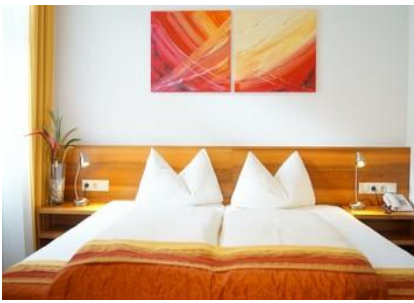

This agreement contains the terms and conditions by which Holidayze (a division of Five Star, Inc.) 810 Belmar Plaza, Belmar, NJ, 07719 ("Operator") in consideration for a Participant's payment, agrees to provide these travel tours. **READ AGREEMENT CAREFULLY BEFORE SENDING ANY MONEY.**

TOUR PRICES: All rates are based on tariffs in effect as of the date of printing. The airfares used for the tour prices indicated herein are capacity controlled and will be applicable on a "first come, first served" basis and are subject to change without notice.

DEPOSITS: As shown on the reverse. Final payment is due December 15, 2018.

PAYMENT: If payment is made by credit card: (1) a signed, fully completed credit card form, for such payment, with proper authorization, must be received to secure reservations and (2) Participant(s) waive any charge back rights for services provided but not utilized. In the event of a dispute, requests for refunds must be made under the procedure described below under the "Refunds" section below. See below for surcharges required for credit card payments.

Cancellations and Refund Policy: Any other person or entity who receives moneys from the Participant(s) does so strictly as an agent for the Participant(s). The Operator disclaims liability for such moneys until received by the Operator's office and confirmation is issued by the Operator. Tender of a deposit constitutes acceptance of these terms and conditions. Complete payment must be received no later than 60 days prior to departure. No changes will be accepted within 6 weeks of departure. Changes that affect inventory utilization (e.g. date change, hotel change, etc.) will be considered a cancellation.

CHANGES/SUBSTITUTIONS: A \$100. fee will be charged for any changes in the reservation that is requested after 60 days prior to departure (December 15, 2018. Substitutions under this provision can only be made up to 45 days prior to departure. (January 2, 2019)

CREDIT CARD PAYMENTS: Surcharges for CC payments are as follows: Master Card or Visa: 3.5%; AMEX: 4%

CANCELLATION CONDITIONS: Certain commitments for these arrangements have been, or are being made on your behalf in connection with the tour described on the reverse. Naturally, along with these commitments comes a certain responsibility on your part that will necessitate certain cancellation penalties in the event you cancel your tour arrangements prior to the departure date. All notices of cancellation must be received in writing at our office in order to be considered valid. The amount of refund, if any, will be determined by the following schedule in accordance with the date such notice is received: Prior to November 15, 2018.: NO PENALTY; Between November 16 & December 15, 2018: \$250. Between December 16 & January 15: \$550.*; After January 16, 2019: Full Penalty. (*Plus any further charges assessed by hotels, suppliers and airlines.) No shows are non-refundable. Charges indicated are **per person.**

PASSPORTS/VISAS: All U. S. citizens are required to have a Passport for International Travel. Obtaining the Passport is the responsibility of the participant. Applications can be downloaded from the Internet at: www.travel.state.gov/passport_services.html **IMPORTANT: ALL PARTICIPANTS MUST SEND A COPY OF THE PHOTO AND INFO PAGE OF THEIR PASSPORT TO THE GROUP LEADER UPON 1ST DEPOSIT.** All U. S. Citizens participating in this tour program are required to have a U. S. Passport valid for at least 6 months beyond the return date of the tour. Any non-U. S. Citizens participating in this tour must check with the appropriate consulate for all countries being visited and transited, to ensure that they have met all entry requirements. It is the participant's responsibility to be sure that all proper entry requirements are met and that they have all the appropriate documents necessary. **The Airlines will not let you board the aircraft if your passport is EXPIRED.**

LAND TRANSPORTATION: Ground transportation, as indicated, will be provided by deluxe motor coaches. In the event of insufficient participation, alternate means of transportation may be provided or offered.

HOTELS/MOTELS: Accommodations will be as indicated except in the case of overbooking. However, the tour operator reserves the right to substitute hotels of a similar category

LIFT TICKETS: Lift tickets are optional and can be pre-purchased with the tourist office or at the lift stations.

MEALS: Any meals included will be as indicated on reverse.

BAGGAGE: Before embarking on this tour it is important that each tour member be fully aware of the baggage restrictions. Specifically, each passenger is allowed 1 checked piece not to exceed 50lbs or larger than 62" (L+W+D). One carry-on is also permitted but must be able to fit under the seat or in the overhead bin. Any luggage in addition to this will be subject to excess baggage charges which are charged PER FLIGHT, EACH WAY and currently are \$287per bag, per flight. All members of the group **will** be subject to excess baggage charges if they are over the limit.
